Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs.5.25 crore bank facilities of Precise Technologies (PT). The rating continues to be flagged as "Issuer Not Co-operating" and is based on the best available information.

About the Company

Maharashtra-based, Precise Technologies (PT) is a partnership firm established in 2017 by Mr. Kshitij Zavare. The firm is engaged in processing of fuel oil out of waste plastic. The firm caters to industrial companies for the sale of oil. The firm has set up a manufacturing unit at Supa, Ahmednagar and has an installed capacity of 12 tonnes per day, which generates 6000 liters of oil per day.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavoured to gather information about the entity/ industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit ratings are based.
