Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 12.00 crore bank facilities of Guru Gobind Foods And Agro Private Limited (GGFAPL). The rating continues to be flagged as "Issuer Not Co-operating" and is based on best available information.

About the Company

Incorporated in 2013, Guru Gobind Foods And Agro Private Limited (GGFAPL) is a Punjab-based company engaged in processing and milling of basmati and non-basmati rice with an installed capacity of 14 Tons per hour (TPH). The company is promoted by Mr. Shaminder Singh Sandhu and it sells rice under the brand name Naymat and Zafran.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
