Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs 9.72 crore bank facilities of Mahesh Silk Mills Private Limited (MSPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Mahesh Silk Mills Private Limited (MSPL), based at Surat, was incorporated in 1993 and promoted by Mr. Vishnukumar Harlalka and Mr. Nurulhaq Kapadiya. The company is engaged in the dyeing and printing of grey silk fabric. The finished product is used as silk sarees and dress material for ladies. It also undertakes processing of grey silk fabric on job work basis.

Unsupported Rating

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
