Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 6.50 crore bank facilities of Amam Marketing (AM). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Established in 2008, Amam Marketing (AM) is an Ahmedabad-based partnership firm engaged in the trading of construction materials such as cement, steel (TMT Bars), ready mix concrete (RMC), motor and chemical for cement. Amam Marketing (AM) is an exclusive sales promoter of J. K. Laxmi Cements

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain.
