Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs. 8.00 crore bank facilities of Tekwissen Software Private Limited. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Incorporated in 2011, Tekwissen Software Private Limited is a Vishakhapatnam based software development company. It offers technology solutions, high-end consulting, system integration, web designing, software development, and technology staffing services to customers in India as well as outside India. It has three offices located at Visakapatnam, Surat and Bangalore. Tekwissen is a privately held company with Mr. Rajeev Kumar Senta and his brother, Mr. Manish Kumar Senta, each holding 50 per cent of the shareholding.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
