**Rating Rationale**

Acuite has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) and the short-term rating of ‘**ACUITE D**’ (read as **ACUITE Do**) on the Rs 21.00 crore bank facilities of Jagdamba Liquified Steels Limited. The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

**About the Company**

New Delhi based, Jagdamba Liquified Steels Limited (JLSL), was incorporated in 1993 and is promoted by Mr. Hari Mohan Lohia and Ms. Usha Lohia. Company is engaged in the manufacturing of specialty steel castings, classified as safety components. These components are primarily used for industries such as Indian Railways, Defense services, auto industry and engineering companies. The company is a class 'A' foundry approved by RDSO. Currently, the company has two production facilities located at Roorkee with a total installed capacity of 15000 MTPA.

**Unsupported Rating**

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
