### Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A4**) on the Rs. 6.00 Crore bank facilities of Standard Doors. The rating continues to be flagged as "Issuer Not Co-operating" and is based on the best available information

### About the Company

Standard Doors (ST) is a Hyderabad-based partnership firm established in 2002 by Mr. Mohan Reddy. It is engaged in the manufacturing of moulded skin doors, plywood flush doors and panel boards. The manufacturing facility is located at Medchal (Hyderabad). The firm imports raw materials such as skins and timber from Malaysia, USA, among others and sells 70 per cent of the stock to SM Corporation.

### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

### Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavoured to gather information about the entity/ industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
