

Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minus) and the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 6.00 Crore bank facilities of Standard Doors. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Standard Doors (SD) is a Hyderabad-based partnership firm established in 2002 by Mr. Mohan Reddy. It is engaged in the manufacturing of moulded skin doors, plywood flush doors and panel boards. The manufacturing facility is located at Medchal (Hyderabad). The firm imports raw materials such as skins and timber from Malaysia, USA, among others and sells 70 per cent of the stock to SM Corporation.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
