

## **Rating Rationale**

Acuité has reaffirmed the long-term rating of 'ACUITE B+' (read as ACUITE B plus) on the Rs. 6.50 crore bank facilities of Shakti Agrotech Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

## About the Company

Shakti Agrotech Private Limited (SAPL) was incorporated in 1996 and is promoted by Mr. Praveen Goyal and Mr. Puneet Goyal. The company is engaged in processing and marketing of seeds of crops like cotton, guar paddy, bajra, mustard, to name a few. The processing facility is located in Sri Ganganagar, Rajasthan.

## Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
