Acuité has withdrawn the long-term rating of '**ACUITE B**' (**read as ACUITE B**) and the short term rating of '**ACUITE A4**' (**read as ACUITE A four**) on the Rs.6.30 crore bank facilities of Sharda Roadlines (SR). The rating withdrawal is in accordance with the Acuité's policy on withdrawal of rating. This rating is now an indicative rating and is based on the best available information.

The rating is being withdrawn on account of request received from the company and NOC received from the banker.

Sharda Roadlines (SR) is a Bhopal (Madhya Pradesh) based proprietorship firm established in 1988. It is engaged in providing transportation services to Food Corporation of India and MP State Civil Supply Corporation. The firm is promoted by Mr. Kamlesh Mittal, who has more than three decades of experience in the industry.

#### Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

CRISIL, vide its press release dated August 31, 2020 had denoted the rating of Sharda Roadlines (SR) as 'CRISIL B+/Stable/A4 (Issuer Not Cooperating)' on account of lack of adequate information required for monitoring of ratings.

Acuité is yet to receive the latest No Default Statement (NDS) from the rated entity, despite repeated requests and follow-ups.
