#### **Rating Rationale**

Acuité has downgraded the long-term rating to **'ACUITE B' (read as ACUITE B)** from **'ACUITE B+' (read as ACUITE B plus)** on the Rs. 6.50 crore bank facilities of Bhatia Agency (BA) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### About the Company

Rajasthan-based, Bhatia Agency (BA) is a proprietorship concern established in 1988 at Kota (Rajasthan). It is engaged in trading of electronic items and home appliances such as air conditioner, refrigerator, Kent R.O, water cooler to name a few. It has one showroom with 3 floors and 2 godowns with built-up area of 9000 sq. feet located in Kota. The sole proprietor of the firm is Mr. Rajkumar Bhatia.

#### Unsupported Rating

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
