Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) and the short term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 25.50 crore bank facilities of Renny Steels. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Renny Steels (RS) was established in 2006 as a partnership concern and is promoted by Mr. Ravinder Malik and Mrs. Prabha Malik. The firm is engaged in manufacturing of iron and steel ingots; round, flat, hexagonal bars from iron scrap and rounds, squares from steel. The firm procures its raw materials from Delhi and Himachal Pradesh and sells its products to its customers based in the northern region of the country. The firm has its manufacturing unit located in Baddi (Himachal Pradesh).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit
