Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minus) on the Rs. 5.65 crore bank facilities of Sri Parameswara Agro (SPA). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Established in 2014, Sri Parameswara Agro (SPA) is a Mahbubnagar based partnership firm engaged in the maintenance of Poultry Layer birds Farm and selling of eggs. This firm is managed by Mrs. B. Kavitha and Mrs. B. Sunitha as partners. The firm has the capacity to maintain around 1,50,000 layer birds.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
