Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 25.00 crore bank facilities of Sheela Avenues Private Limited (SAPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Incorporated in 2014, Sheela Avenues Private Limited (SAPL) is a Hyderabad-based real estate company promoted by Mr. C Venkateshwarlu. It is into the development of real estate projects (both commercial and residential) in and around Hyderabad (Telangana).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
