Rating Rationale

Acuite has withdrawn the short-term rating of '**ACUITE A3**' (read as **ACUITE A three**) on the Rs. 446.00 crore bank facilities of WORLD CREST ADVISORS LLP (WCAL). We have received the requisite documents related to closure of rated bank facility and the rating withdrawal is in accordance with Acuite's policy on withdrawal of rating.

World Crest Advisors LLP (WCAL) established in 2016 is a part of Essel Group, the leading industrial group with significant presence in media, entertainment, technology, infrastructure, packaging, financial services and education among others.
