Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 27.00 crore bank facilities of Pavani Polymers Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Pavani Polymers Private Limited (PPPL) is a Kurnool (Andhra Pradesh) based company incorporated in 2012, promoted by Mr. Prathap Reddy Arasu and his family members. The company is engaged in the manufacturing of woven sacks and laminated sacks. The manufacturing plant located is in Nandyal with an installed capacity of 4752 metric tonnes per annum (tpm).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for

conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
