### Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 8.74 crore bank facilities of Himmat Singh Antar Singh (HSAS) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### **About the Company**

Established in 1982, Himmat Singh Antar Singh is a proprietorship firm engaged in civil construction of roads for government (95%) and private entities (5%). The firm is an A-grade contractor who undertakes contracts of government entities in and around Indore. It is operated by Mr. Himmat Singh who has experience of more than 33 years.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit

such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
