Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minus) and the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 7.00 crore bank facilities of Tec Workshop Interiors India Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Incorporated in 2006, Tec Workshop Interiors India Private Limited is a Chennai-based company promoted by Mr. Anil Tewari and Mrs. Sarita Tewari. The company is engaged in manufacturing and execution of interior decoration projects for brands such as ITC Hotels, The Oberoi Group, Taj Group of Hotels, GRT Hotels, Triguna Group and TCI Group, among others. The company has 25,000 sq. ft. facility in Chennai (Tamil Nadu) for manufacturing of furniture and fixtures.
