Acuité has reviewed the long-term rating of '**ACUITE B-** (read as **ACUITE B minus**)' on the Rs.7.50 crore bank facilities of Vidya Educational Society. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Vidya Educational Society is a trust that started Vidya Sanskar International School (VSIS) in the year 2006. VSIS is a Cambridge University affiliated 10+2 school. The school also provides hostel facility. The trust has 12 founder members.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
