Rating Rationale

Acuite has reaffirmed the long term rating of 'ACUITE D' (read as ACUITE Do) n the Rs.17.00 Cr. bank facilities of Alin Cashews. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Established in 2006, Alin Cashews a Quilon, Kerala based partnership firm engaged in processing and exporting of cashews. The firm is promoted by Mr. Shihansha and Mrs. Shanimol. Currently, the company owns 4 processing units and 6 rented units with a processing capacity of 20 tonnes per day.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
