Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs.11.50 Crore bank facilities of Alepa Dairy Foods Private OPC Limited (ADF). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Bangalore-based, Alepa Dairy Foods Private OPC Limited (ADF) was incorporated in 2016 by Mr. S Ravikrishna. ADF is engaged in milk production and its processing, co-packaging activity. The company has launched two different brands, 'Alepa' for premium bottled milk and 'Atheya' regular pouch milk and curd. ADF provides co-packaging facility to Parag Milk Foods.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity / industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
