# Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minus) on the Rs.11.50 Crore bank facilities of Alepa Dairy Foods Private OPC Limited (ADF). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information

# **About the Company**

Bangalore-based, Alepa Dairy Foods Private OPC Limited (ADF) was incorporated in 2016 by Mr. S Ravikrishna. ADF is engaged in milk production and its processing, co-packaging activity. The company has launched two different brands, 'Alepa' for premium bottled milk and 'Atheya' regular pouch milk and curd. ADF provides co-packaging facility to Parag Milk Foods.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
