## Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) and reaffirmed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.40.00 crore bank facilities of Tirupur Pandit Hosiery Millss Private Limited (TPPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

## About the Company

Tamil Nadu-based, Tirupur Pandit Hosiery Millss Private Limited (TPHM) was established as a partnership firm in 1974 and in 2004, the constitution was changed to a private limited company. The company is engaged in manufacturing of readymade garments (RMG) for male, female and kidswear. TPHM is a 3-star export house (recognised by Government of India) and ISO 9001 certified company. TPHM is incorporated in 1974 by Mr. N. Subramanian and Mr. P. Padmanaban.

## Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
