Rating Rationale

Acuite has downgraded the long-term rating to **'ACUITE B' (read as ACUITE B)** from **'ACUITE B+' (read as ACUITE B plus)** and reaffirmed the short-term rating of **'ACUITE A4' (read as ACUITE A four)** on the Rs. 16.00 crore bank facilities of Aswath Saw Mill (ASM) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Established in 1994, Aswath Saw Mill is a proprietorship firm based out of Shenkottai (Tamil Nadu) engaged in trading of timbers. The firm is promoted by Mr. Maguthu Meeran, who has more than 4 decades of experience in the trading industry.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
