#### Rating Rationale

Acuité has downgraded the long term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 20.00 crore bank facilities of Sai Datta Constructions on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### About the Company

Incorporated in 2008 as a partnership firm, Sai Datta Constructions is an approved specialclass contractor for executing Government roads and irrigations projects in Telangana region. Based in Warangal (Telangana), the firm is promoted and managed by Mr. K Thrirumal Reddy.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
