### Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) and the short term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 31.07 crore bank facilities of Precision Granite & Marble Private Limited (Precision). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### About the Company

Karnataka based company Incorporated in 1980, Precision Granites & Marbles Private Limited (Precision) is a 100 per cent export-oriented unit. It is engaged in processing of granites and marble blocks into slabs. It has an installed capacity of 2.21 lakh sq meters per annum of granite processing and 3792 cubic meters per annum of marble processing. The company is promoted and managed by Mr. J B Surana, who has around 35 years of experience in the granite processing industry.

### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

### Limitation regarding information availability:
