Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) on the Rs. 6.00 crore bank facilities of Sree Krishnarjuna Steel and Pipe Distributors (SKSPD) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Promoted by Mrs. Kakumanu Kanaka Durga, Sree Krishnarjuna Steel and Pipe Distributors (SKSPD) is a proprietorship concern that commenced operations on 24 March, 1975 as a distributor and trader of GI pipes & MS steel tubes of TATA and Jindal Steels. The firm has its registered office in Vijayawada, Andhra Pradesh. The firm is an authorised distributor of the Tata Steel brand for Tata Galvano brand for galvanised pipes and MS steel tubes of TSL and Jindal Steel since inception.
