Acuité has reviewed long-term rating of '**ACUITE BB+** (read as ACUITE double B plus) and short-term rating of '**ACUITE A4+** (read as ACUITE A four plus) on the Rs. 86.00 crore bank facilities of OCEAN MOTORS PRIVATE LIMITED (OMPL). This rating is now an indicative rating and is based on best available information.

Ocean Motors Private Limited (OMPL) (erstwhile Patel Service Centre), an Indore-based company, was established in 2002 as a proprietorship firm; it was later incorporated as a private limited company in 2011. The company started as a Maruti Authorized Service Station and in 2011 became the dealer of Maruti Suzuki India Limited (MSIL). The company is promoted by Mr. Mahendra Patel (Managing Director) and Mr. Ravi Nagar (Director).

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
