The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

AdCcept Technologies Private Limited (ATPL) a West Bengal based company was incorporated in the year 2009, by Mr. C.S Banerjee and Mr. S.K De. The company is engaged into design, supply, delivery assembly, system integration, installing, commissioning and service provider for government and semi government entities.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
