Rating Rationale

Acuite has downgraded the long-term rating to **'ACUITE B' (read as ACUITE B)** from **'ACUITE B+' (read as ACUITE B plus)** on the Rs. 9.62 crore bank facilities of Naveena Printing Mill (NPM) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Established in 2009, Naveena Printing Mill (NPM) is Erode based partnership firm promoted by Mr. A Rajkumar. The firm is engaged in printing of woven and knitted fabrics. The entity has a processing plant in Erode with an installed capacity of 90000 meters per day. It is also certified by GOTS (Global Organic Textile Standards). The entity was incorporated as a proprietorship firm in 1993 and was converted to partnership firm in 2009.

Unsupported Rating

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
