Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE C**' (read as **ACUITE C**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs. 7.10 crore bank facilities of Srusti Agro Farms Private Limited (SAFPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on best available information.

The downgrade is based publicly available information CRIF Highmark report.

Mahulpunji-based, Srusti Agro Farms Private Limited (SAFPL) was incorporated in 2016 and is promoted by Mrs. Mamta Puhan and Mr. Nirakar Puhan, among others. The firm will engage in the production of eggs with a capacity of 99000 eggs per day.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
