Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 10.00 crore bank facilities of Aaress Enterprises. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Aaress Enterprises is a partnership firm formed in 2011 by Mr. Ricky Bhasin and Mr. Pran Bhasin. The firm is engaged in manufacturing of precision machine components and sheet metal. The manufacturing facilities of the firm are based in Faridabad (Haryana).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
