Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE single B**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A Four**) on the Rs.10.00 Crore bank facilities of Aureole Inspects India Private Limited. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Aureole Inspects India Private Limited (AIPL) a Delhi based company was incorporated in 2002 by Mr. Vineet Sharma, Mrs. Amrita Khurana Sharma, Mr. Christopher Brian Davidson Smith, Mr. Vivek Kak. The company is MSME registered and is engaged in manufacturing of Snow Goggles, All-terrain goggles, fashion eyewear amongst others. The company sells 90 percent of its products to Indian Defence and 10 percent through e-commerce websites like Jabong, Flipkart, Myntra, to name a few.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain.
