Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) and reaffirmed the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.14.00 crore bank facilities of Acaricide India Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Established in 1995, Acaricide India Private Limited (ACARICIDE) is engaged in the field of agrochemical manufacturing and offering wide range of pesticide formulations to the farmers for crop protection chemicals viz insecticides, miticides, fungicides, herbicides, micronutrients; in liquid and solid formulations. The company operates from its manufacturing facility located at Satulur village, Nadendla Mandal, Narasaraopet, Guntur District, Andhra Pradesh State with an installed capacity of ~ 20000 metric tonnes /per annum It has its registered office in Hyderabad, Telangana. At present the company led by Mr. Sreenivasa Rao Kurapati with his wife Mrs. Lakshmi Sujatha Kurapati.
