Acuité has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 6.50 crore bank facilities of Taj Shailani Cotton Industries. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Established in 2016, Taj Shailani Cotton Industries is a Jangaon (Andhra Pradesh) based partnership firm engaged in the processing (ginning and pressing) of cotton with a capacity of 1300 quintals per day. The entity has an experienced management. Mr. Mohammed Abdul Aziz, the founder of the entity has more than a decade of experience in the same line of business.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
