The issuer did not co-operate; based on best available information.

Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) on the Rs. 6.50 Cr bank facilities of Taj Sailani Cotton Industries on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Established in 2016, Taj Sailani Cotton Industries is a Jangaon (Andhra Pradesh) based partnership firm engaged in the processing (ginning and pressing) of cotton with a capacity of 1300 quintals per day. The entity has an experienced management. Mr. Mohammed Abdul Aziz, the founder of the entity has more than a decade of experience in the same line of business.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
