Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 7.49 crore bank facilities of Unitforce Technologies Consulting Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Incorporated in 2005, Unit Force Technologies Consulting Private Limited (UTPL) is a Bangalore (Karnataka) based company which is promoted by Mr. N.S. Natesh and Mrs. Somasekhar. The company provides staffing and IT services to various Multi-National Companies and institutions. UTPL has around 100 professionals working in projects across India.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
