Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B+' (read as ACUITE B plus) on the Rs. 39.00 crore bank facilities of 3B Flims Private Limited (3B Films). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Incorporated in 2014, 3B Films Private Limited (3B Films) is a Gujarat-based company engaged in the manufacturing of Cast Polypropylene (CPP) films used in flexi packaging. The company is promoted by Mr. Ashok Babariya. 3B Films caters to the clients like Huhtamaki PPL Ltd, Amcor, Uflex, which are engaged in flexible packaging. The company has its manufacturing unit located at Jambusar Highway (Gujarat State Highway) with an installed capacity of 7200 MTPA.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
