Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs. 39.00 crore bank facilities of 3B Films Private Limited (3B Films) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Incorporated in 2014, 3B Films Private Limited (3B Films) is a Gujarat-based company engaged in the manufacturing of Cast Polypropylene (CPP) films used in flexi packaging. The company is promoted by Mr. Ashokbhai Dhanjibhai Babariya, Mr. Mukesh Dhanjibhai Babariya, Mrs. Gulabben Nitin Babariya. 3B Films caters to the clients like Huhtamaki PPL Limited, Amcor, Uflex, which are engaged in flexible packaging. The company has its manufacturing unit located at Jambusar Highway (Gujarat State Highway) with an installed capacity of 7200 MTPA.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
