Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as ACUITE D) on the Rs. 10.00 crore bank facilities of Harishankar Paper Products Private Limited (HPPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Incorporated in 1996, HPPL is a Hyderabad-based company, which is promoted by Mr. Shiv Shankar Taparia and Mr. Ram Kishore Taparia. HPPL is engaged in trading of Paper and Paper products. It is also authorised distributor of Seshasayee Paper and Boards Limited in the region of Telangana.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
