Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) on the Rs. 7.00 crore bank facilities of Sri Laxmi Venkatadri Agro Foods on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Incorporated in 2008, Sri Laxmi Venkatadri Agro Foods is engaged in delinting of cotton seeds, cotton oil extraction and processing of bi-product of rough / de-oiled cake. Based in Raichur (Karnataka), Sri Laxmi Venkatadri Agro Foods is promoted and managed by Mr. K. Narendra Babu. It has a crushing unit (oil mill) and Cotton Delinting plant with an installed capacity of 200 tonnes per day (TPD) and 300 tons per day (TPD).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
