**Rating Rationale**

Acuité has downgraded the long-term rating to '**ACUITE B**' (**read as ACUITE B**) from '**ACUITE B+**' (**read as ACUITE B plus**) on the Rs. 20.60 crore bank facilities of Prakash Technoplast India Private Limited (PTIPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

Prakash Technoplast India Private Limited (PTIPL) was incorporated in 2010 by Mr. Prakash M Valecha and Mr. Jeetendra M Valecha. PTIPL is engaged in the manufacturing of plastic and bellow moulded products. The manufacturing plant is based out of Hosur (Tamil Nadu) and has the capacity of processing 4000 tons of plastic annually.

**Unsupported Rating**

**Non-cooperation by the issuer/borrower:**

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
