Rating Rationale

Acuite has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 4.60 crore bank facilities of ACME Toolings on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Established in 2001 by Mr. Rajan K, Acme Toolings is a Hyderabad (Telangana) based proprietorship firm. The entity is engaged in manufacture of thermoset and thermoplastic moulds which find application in Electrical, Electronics, Home Appliances and Automobile segments. The entity has an installed capacity to produce 200 moulds per year of sizes varying from few kgs to a ton as per client specifications.

Unsupported Rating

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and

Acuité's policies.
