Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D' (read as ACUITE D)** on the Rs. 87.00 crore bank facilities of Arya Nautica Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Mumbai-based, Arya Nautica Private Limited was incorporated in 2013. The company commenced its ship chartering operations in November 2017 with the acquisition of its first medium range tanker Dawn Shirdi. The company is part of Arya group which is also engaged in trading of iron & steel, ship breaking among others. The group owns a fleet of 7 medium range tankers with 31069 to 46801 Dead Weight Tonnage (DWT). Mr. Varun Arya and Mr. Ravi Arya are current directors of the company.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored together information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
