Rating Rationale

Acuité has downgraded the long-term rating to ‘**ACUITE B-**’ (read as **ACUITE B minus**) from ‘**ACUITE B**’ (read as **ACUITE B**) on the Rs.10.00 crore bank facilities of Shakthi Vetfeeds India Private Limited (SVPL) on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Established in 2011 and based in Hyderabad (Telangana), Shakthi Vetfeeds India Private Limited (SVPL) is promoted and managed by Mr. M Vidya Sagar Reddy. SVPL is a manufacturer of poultry feed with an installed capacity of 12.5 tonnes per hour (TPH).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
