Rating Rationale

Acuite has downgraded its long-term rating to ‘**ACUITE C**’ (read as **ACUITE C**) from ‘**ACUITE B+**’ (read as **ACUITE B Plus**) on the Rs.17.00 Cr. bank facilities of Tanya Automobile Private Limited (TAPL). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information. The downgrade is based on delays in debt servicing in recent months being reflected in the Credit Information Bureau Report of the company.

About the Company

The Meerut-based, Tanya Automobile Private Limited (TAPL) was incorporated by the Garg family in 1995. The company is an authorized car dealer for Maruti Suzuki and has two own showrooms. It also runs service a center, a training school for Maruti Suzuki. The present directors of the company are Mr. Harsh Garg and Ms. Shalu Garg.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.

Limitation regarding information availability

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain. Any rating with the suffix 'Issuer not cooperating' is assigned without any management interaction with the issuer entity or any data / information from the entity. Sometimes this non co-operation by a rated entity may be due to a result of deterioration in the credit risk profile of the entity. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
