Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 7.00 crore bank facilities of Advanced Enterprises. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Established in 2003, Advanced Enterprises is a Haryana-based partnership firm promoted by Mr. Hemant Khera and Mrs. Seema Khera. The firm is engaged in manufacturing of industrial gears and gearboxes. The firm diversified its product line to manufacturing machines for pvc pipes and profiles. The firm has its manufacturing unit located at Bahadurgarh, Haryana with installed capacity of manufacturing 2000 units of gear case per annum and 24 units of pvc pipe machines per annum.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity / industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
