Rating Rationale

Acuite has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) on the Rs.6.00 crore bank facilities of Reliable Agencies on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Reliable Agencies was originally established in 1992 as a proprietorship by Mr. M.Venkata Ratnam. Post his demise in September 2013, Mr. Mohan Babu (his son) has taken the charge of the entity. The firm is engaging in the business of distribution of welding equipment and its consumables. The firm is an authorised supplier of Bosch Power Tools, Ador Fintech Ltd, D&H Secheron Electrodes Private Limited, Mailam India Ltd, Schutz Carbon Electrodes Pvt Ltd, Carborandum Universal Ltd and Others in the Hyderabad region of Telangana.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
