Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B+' (read as ACUITE B Plus) on the Rs.7.60 Crore bank facilities of K P Stones(KPS). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

KPS established in 2014, is a Rajasthan based firm primarily engaged in the processing and trading of marble with a processing capacity of 10,000 sq.ft. Per day for imported marble blocks. The firm sells marbles under its own brand name 'My Stone'. The marble slab processing unit is situated at Kishangarh (Rajasthan) and has three gang saws. The present promoters of the company are Ms. Kalpana Devi Jain, Ms. Purvi Jain and Ms. Rashmi Rathore.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
