Acuité has downgraded the short-term rating to '**ACUITE A4**' (read as **ACUITE A four**) from '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs. 20.50 crore bank facilities of Vandemataram Projects Private Limited (VPPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

VPPL, incorporated in 2006, is an Ahmedabad-based company engaged in civil construction work for residential projects and caters to the government under the Pradhan Mantri Awas Yojana in Gujarat.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
